I. POSITION SUMMARY

This position will ensure all aspects of shipping and receiving are met. Prepares goods for shipment and checking in deliveries. Stock shelves, rotate inventory and participate in physical inventories. This position supports and is accountable for the Quality and Food Safety policies in place by the company.

ESSENTIAL POSITION RESULTS

- Ensures successful receipt of freight and goods by manually unloading or using forklift and other types of equipment
- Guarantees accurate delivery of orders by ensuring quality and count are correct and match purchase orders
- Confirms delivery of samples and finished goods by preparing product wrapping
- Maintains warehouse goods by stocking shelves and rotating goods
- Maintains inventory records by adding and deleting supplies as they are shipped and received and participates in physical inventories
- Records delivery and receipt of goods by operating handheld devices such as scanners and entering data in computer programs
- Confirms successful execution of goods received and delivered by communicating with management team regularly regarding issues and concerns
- Maintains a safe and clean working environment by complying with safety procedures, rules, regulations and keeping warehouse racking and yard clean and free of obstruction
- Contributes to team effort by accomplishing related results as needed
- Maintains customer confidence and protects operations by keeping information confidential
- Checks for damaged goods, quantity and quality of the incoming material or shipment and verifies items against a purchase order
- Stocks shelves and rotates inventory; may receive, store, and ship flammable, explosive, or combustible materials
- Participates in physical inventories of warehouse and/or supply yard; maintains inventory records by adding or deleting supplies as they are shipped or received

- May prepare damage claims for QA's review and signature; may coordinate disposal of surplus property and manage records
- Maintains a safe and clean working environment by complying with safety procedures, rules and regulations. Keep warehouse racking and yard clean and free of obstruction
